NEW: \$1590.00 received from the Howard Klann (KD8ABP) Estate. The Secretary (W8FWG) will send a note of thanks to the family of Howard, KD8ABP.

NEW: Simplex connection in the Houghton/Hancock area via 449.315 MHZ (Simplex) PL of 100.0 needed.

NEW: Add Amendment #36 deleting name of Howard Klann KD8ABP, suggest putting inW8EEK. HOLD: Ask Stewart if he would be willing to be added to the A/T Committee.

NEW: Member Erik Lee requested help in putting up a doublet antenna on the CAP frequencies at his residence in Laurium. KCRA members will help with that project

NEW: George, W8FWG was contacted by Barbara Keeley of Chassell, whose husband John, WU3H recently passed away. W9GY and W8FWG will assist her in helping to sell his amateur radio gear.

NEW: W8FWG found that the license of Richard Brooks, KB8FCX had expired in August. Fortunately he is still within the two-year grace period and has been contacted to renew his FCC issued General Class license.

NEW: An upgraded list shows that the KCRA now has 34 members.

NEW: Bill, KD8JAM will inspect the tower site when the weather clears. Thank you, Bill.

NEW: Stuck mic. problem of amateur radio ops discussed. There is a real need for people with beam antennas to help in locating these stations by triangulation. If you have a beam with a rotator on it, we are looking for your help!

UPDATE: The problem of "grow lights" was brought up by George, W8FWG, and he discussed how to handle the trouble reporting of these kinds of problems, to the ARRL, who in turn notifies the FCC, and a form letter is send out to the person(s) who are causing the radio interference in the HF HAM bands. They have to reply to the FCC within 30 days of corrective measures taken.

SUMMARY OF THE 2018 LSPR:

The Lake Superior Performance Rally will be held in Houghton, MI October 18 -20, 2018. The event is Round #8 of the Rally America National Championship. LSPR includes two Regional Rallies, the Ottawa Rally run on Friday, October 19th, and the Lac Vieux Desert Rally run on Saturday, October 20st.

This year marks the 24nd Anniversary of a Lake Superior Performance Rally. The Lake Superior Region officially assumed production of this event in 1994.

The event starts at 8:00AM Wednesday October 17th, 2018 and ends after the Awards Party on Saturday October 20th, 2018. Between those times all competitors and crews are expected to follow all Rally America Rules for Safety, Competition and Conduct.

The event will be conducted according to the Rally America Performance Rally Rules 2018 Edition (PRR) and these Supplemental Regulations including any Bulletins signed and posted.

The OFFICAL NOTICE BOARD will be located at the Headquarters from the start of registration until the close of registration and at MTCs and service areas during the event. After the finish, the notice board will relocate to the awards party.

Location of Parc Expose' & Start and Finish (maps are provided in the Route and Service Route Books)

The Friday Parc Expose' & Start is at Country Inn & Suites, 919 Razorback Dr, Houghton, MI. The Friday Finish is in Sidnaw, MI.

The Saturday Parc Expose' & Start will be from Front St in L'Anse, MI. The Saturday Finish will be at the end of the Lakeshore Stage, Houghton, MI.

Vehicles will be impounded at the Saturday Finish until released by the Rally America officials. Vehicles may be subject to a post-event technical inspection.

Competitors are required to attend all Parc's Expose in their diving suits. Competition vehicles, Drivers and Co-Drivers must be in Parc Expose by the indicated start times. Arrival times will be recorded and fines (\$100) and penalties will be assessed for failure to arrive on time or to appear.
