# **Engineer's report:**

The old controller that was working with the old Motorola MSR-2000 repeater is now working with the new Yaesu DR-2X repeater. So far, so good — once again we have a voice ID with the time of day, a courtesy beep and autopatch capability.

At the end of May, however, the repeater's output power was noticeably reduced. On-site inspection revealed bad coax on the indoor portion of the transmit line, which was replaced.

Everything connected to the repeater has battery backup now except the VOIP analog phone adapter.

Discussion then turns to a possible replacement for the omnidirectional receive antenna — a 3-element Yagi aimed down the spine of the Keweenaw. Jeff says the Yagi could deliver up to 6 dB of additional gain. Vance moves to spend up to 200; Logan seconds. The motion carries by acclamation.

Balance in the treasury is \$4,463.23, not including approximately \$50 in the PayPal account.

#### Old business:
